Overarching Packaging Requirements

Colorado House Bill 22-0355 on a Producer Responsibility Program for state-while Recycling ontered into force on 10th August 2022 and requires producers of packaging, paper products, and some food service items to pay for and manage the recycling of their covered products.statewhile. The aim of the regulation is to reduce lendfill waste and increase recycling rates. The executive director of the Colorado Department of Public Health and Environment designated a non-profit organization to implement and manage a state-while program that provides recycling services to covered entities in the state (defined as residences, businesses, schools, government buildings, and public places). The program is funded by producers of packaging materials and paper products that are sold, offered for sole, or distributed in the state.

The regulation comes into effect on 25th July when, after this date, a producer is prohibited from selling or distributing any products that use covered materials in the state unless the producer is participating in the EFR Program.

EPR

EPR Scheme Description

The definition of a producer under this regulation includes entities that manufacture, license, or import packaging or paper products sold or distributed in Colorado, including products sold online. This also applies to publishers of specific paper products such as magazines and newspapers.

Producers must participate in the EPR program if they generate \$5.32 million or more in annual revenue or use one tonne or more of packaging materials in Colorado.

Entities exempt from this regulation include:

- State and local governments
- Nonprofits
- Individual businesses operating licensed retail food establishments in Denver
- Agricultural employers with less than \$5 million in gross revenue
- Construction-related companies

Materials exempt from this regulation include:

- Packaging for long-term storage
- Certain paper products that could be unsafe to handle
- Specific FDA-regulated packaging

The Colorado proposed House Bill introduces the EPR scheme and states that producers can comply either individually, or through a PRO. The Bill calls for a single PRO, however, from 1st



January 2029, other non-profit PROs can request to be a part of the program. The appointed PRO for this scheme is Circular Action Alliance (CAA) and its first task is to conduct a needs assessment and use the findings to develop three cost scenarios for reaching state-wide recycling goals. The PRO in Colorado will have decision-making authority and will contract directly with recycling service providers, haulers, processors, and local governments that provide recycling services. The PRO will also be responsible for determining readily recyclable parameters, and will set minimum recycling collection and minimum recycled content rates.

The Bill proposes to **create the producer responsibility program for state-olde respelling advisory** heard. 
